Resolution No. 1/2017 of the Ordinary General Meeting of ULMA Construcccion Polska Spółka Akcyjna seated in Koszajec of 19 October 2017 on election of the Chairperson of the General Meeting

§ 1.

The Extraordinary General Meeting of ULMA Construcccion Polska Spółka Akcyjna seated in Koszajec hereby elects Karolina Borkowska as the Chairperson of the General Meeting.
