Subject: Recommendation of the Management Board of ULMA Construccion Polska S.A. on the distribution of profit for the financial year

The Management Board of ULMA Construccion Polska S.A. (the "Company") announces that on 7 April 2022 it adopted a resolution on accepting a recommendation to the General Meeting of Shareholders concerning the distribution of profit for the financial year 2021 by allocating the entire net profit of the Company for 2021 in the amount of PLN 21,679,848.18 (twenty-one million six hundred and seventy-nine thousand eight hundred and forty-eight PLN and 18/100 PLN) to supplementary capital.

The recommendation of the Management Board is based on an analysis of the Company's current financial capabilities in terms of the necessary investments supplementing the Company's product portfolio, related to increased demand on the domestic market and on export markets under direct supervision of the Company, through its subsidiaries, in particular in connection with operating restrictions caused by the conflict in Ukraine.
